2026 ISLAND BOAT SHOW DEALER TERMS, RULES, AND REGULATIONS

1. Payment for space

- a. Payment to procure guaranteed space requires 25% down by October 1, 2025. Final payments are due by December 1, 2025.
- b. Online payment may be made through requesting an electronic invoice to annier@islandcommunitychurch.org

2. RESTRICTIONS

- a. Island Boat Show is hosted on a tobacco-free campus.
- b. All products and services displayed are subject to approval by Island Boat Show.

3. CANCELLATIONS AND SPACE CHANGES

- a. If a dealer wishes to cancel this agreement, he/she must contact a boat show representative by December 12, 2025, and the cancellation must be confirmed in writing.
- b. Space changes are subject to approval by a boat show representative.

4. SUBLEASING _____

- a. Exhibitors may not sublease any portion of their purchased space.

5. LIABILITY, RELEASE, WAIVER AND INDEMNIFICATION _____

- a. Dealer releases Island Community Church Inc., their officers, directors, employees, agents, and volunteers from any claim, liability, losses, costs or expenses relating to or arising out of any injury to any personnel of exhibitor, or to any other persons or any damage to any property of exhibitor. The Exhibitor shall be responsible for such injury, loss or damage and any expenses relating thereto.
- b. Dealer shall indemnify, hold harmless, defend and reimburse Island Community Church, Inc., their managers, contractors, directors, officers, employees, agents and volunteers from any and all actions, claims, demands, liabilities, losses, attorney fees, cost of litigation which indemnities for any reason resulting from, relating to or arising out of dealer participation in Island Boat Show; including but not limited to the negligence, gross negligence, criminal acts and any injury to or death of any persons or any loss through theft or otherwise damage to property.
- c. This agreement shall be governed by and construed in accordance with the substantive law of the State of Florida.

6. INSURANCE – Dealer is required to provide and keep in force during the show period, including move in and move out periods the following insurance:

- a. Commercial General Liability including products, completed operations, personal and advanced liability with a per occurrence limit of not less than \$1,000,000.
- b. Automobile Liability Insurance with a limit of \$1,000,000 per occurrence.
- c. Additional Named Insured Endorsement must include Island Community Church, Inc. on both Commercial General Liability and Automobile Liability policies. Certificate must be delivered before Jan. 15, 2026 to a boat show representative or mailed to Island Community Church at above address under 1b.
